Ms. Diene Keita [Speaker] Under-Secretary-General of the United Nations and Executive Director, UNFPA

Ms. Diene Keita is the United Nations Under-Secretary-General and Executive Director of the United Nations Population Fund (UNFPA), appointed by the UN Secretary-General in August 2025. She brings over 30 years of leadership in international development, diplomacy, and public service, with a strong commitment to advancing women's and youth empowerment, sexual and reproductive health, and gender equality. Prior to her appointment, Ms. Keita served as UNFPA Deputy Executive Director for Programmes and as the organization's Representative in Nigeria and the Democratic Republic of the Congo. She also served as Minister for Cooperation and African Integration for the Republic of Guinea and has held senior roles within the UN system, including as UN Resident Coordinator in multiple countries. Ms. Keita holds a doctorate in Law and advanced degrees in International Economics, Development Law, and International Relations from the University of Paris 1 Panthéon-Sorbonne.

Ms. Sima Bahous [Speaker] Under-Secretary-General of the United Nations and Executive Director, UN Women


Ms.Sima Bahous is the United Nations Under-Secretary-General and Executive Director of UN Women, appointed in September 2021. A strong advocate for women's empowerment. gender equality, and youth inclusion, she brings over 35 years of leadership experience at national, regional, and international levels. Prior to her appointment, she served as Jordan's Permanent Representative to the United Nations, and as Assistant Administrator and Director of the Regional Bureau for Arab States at UNDP. Ms. Bahous has also held senior positions with the League of Arab States and in the Government of Jordan, including as Adviser to King Abdullah II and President of the Higher Media Council. She holds a PhD in Mass Communication and Development from Indiana University, an MA in Literature and Drama from Essex University, and a BA in English Literature from the University of Jordan.

Camilla Waltersson Grönvall has been Sweden's Minister for Social Services since 2022.

Before joining HelpAge International, Mr. Mathews held senior roles in international NGOs and development organizations, focusing on poverty reduction, community resilience, and rights-based approaches to development. He is widely recognized for his strategic vision and commitment to ensuring that ageing is addressed as a central pillar of sustainable and inclusive development.



Ms. Leyla Sharafi [Moderator] Chief, Gender, Human Rights and Inclusion Branch Programme Division, UNFPA/HQ

Ms. Leyla Sharafi is the Chief of the Gender and Human Rights Branch in the Technical Division at the United Nations Population Fund (UNFPA) in Headquarters. Levla's role at UNFPA is to coordinate the organization's gender mainstreaming efforts, and manage global gender and human rights programmes including those related to women and girls facing multiple and intersecting forms of discrimination. Leyla coordinates UNFPA's system wide accountability on disability inclusion, and manages UNFPA' flagship initiative We Decide to promote the rights of women and young persons with disabilities. Leyla brings with her more than 20 years of international work experience at the United Nations including at UNFPA, UNIFEM, the Executive Office of the Secretary General, and UNDESA. Prior to joining the UN, Levla worked





in the media sector both in an NGO in Ghana, and as a journalist and editor for a number of years.

Ms. Aparna Mehrotra [Speaker & Moderator] Director, UN System Coordination Division and Senior Executive Advisor on Ageing, UN Women

Ms. Aparna Mehrotra is the Director of the UN System Coordination Division and Senior Executive Advisor on Ageing at UN Women. She serves as Secretary of the Inter-Agency Network on Women and Gender Equality (IANWGE) and Chair of its Working Group on Ageing, and a member of the Inter-Agency Group on Ageing, advancing system-wide coherence and accountability.

With over four decades of UN service across four continents—Africa, Asia, Latin America, and North America—she co-founded and led the development of the UN System-wide Action Plan (UN-SWAP), the UN's accountability framework for gender equality. Earlier, she pioneered the first inter-agency campaign on violence against women across 13 countries in Latin America and the Caribbean, and served with the Special Adviser of the Secretary-General for Iraq, contributing to the Security Council-mandated International Advisory and Monitoring Board for Iraq.

Previously, she was the UN Focal Point for Women, leading initiatives on gender parity, inclusive organizational culture, and anti-harassment policies. Her work continues to bridge policy, reform, and coordination to embed gender equality and a life-course perspective—including ageing—across global development frameworks.
